ITEM 5 PLANNING MATTERS

5.1 Results of Planning Applications (pntc)

435 **35584/004 Old Dairy**, Ryebriidge Lane, Upper Froyle, RE-POLLARD TO PREVIOUS POLLARD POINTS (FINISHED HEIGHT ABOUT 8 METRES) AND CROWN LIFT TO 4 METRES, 5 LIME TREES (1,2,5,6 & 7 IN NOTIFICATION). FELL 2 LIME TREES (TREES 3 AND 4 IN THE NOTIFICATION). ALL ADJACENT TO THE EASTERN MOST BOUNDARY. NO OBJECTION Noted

437 HCC: **22111/031 West End Farm**, change of use to waste wood shredding: refusal. Details had been enclosed with the agenda. Noted.

5.3 Other Planning Matters & Matters Arising from previous

439 Fabrik: **Husseys Lane willow felling**: tree will be felled on 07/08 March. Noted

ITEM 6 OTHER MATTERS

6.1 Patio pointing (deferred from FPC 28.1.13)

Mr. Wells agreed to ask DC Andrews for two quotations: one for replacement of one third of the pointing, and one for replacement of all the pointing. **Miss Gove** agreed to get a quotation from R Croft to compare with DC Andrews.

6.2 Swings: replacement or repair (deferred from FPC 28.1.13).

It was agreed that all the seats and shackles should be replaced and to do it as soon as possible. **Mr. Cray** to provide costing.

ITEM 7 CORRESPONDENCE RECEIVED

A list of the correspondence received since the agenda for the meeting of 27th February 2013 had been prepared had been enclosed with the agenda. Noted.

ITEM 8 REPORTS FROM COUNCILLORS AND OFFICERS

8.1 Mr. Whines reported that new **doors** for the **Football Hut** had been ordered.

8.2 Mr. Lloyd had attended a meeting with Dist. Cllr. Glynis Watts and Ken Carter regarding **parking at Bentley Station**. He said there would be more restriction on parking in Station Road, but it may be possible to extend the car park towards the Bentley-Frith End Road or to use an adjacent field. Mr. Carter would contact Alton Rail Users Group. There may be funds to run shuttle buses.

8.3 Disabled parking bay in Westburn Fields: Miss Gove had visited the resident. It was agreed that in icy conditions and during periods when most residents are at home, ie other cars are parked in the road, it could be a hazard. It was agreed the **Clerk** would speak to Radian to ask them to make a parking space in the resident's front garden instead, explaining the possible hazard of its present position and reporting that the police had been called because of friction, and to ask them to visit the site. **Mr. Wells** and **Mr. Goodsell** agreed to attend a site visit by Radian.

ITEM 9 MATTERS RAISED BY COUNCILLORS

9.1 It was agreed that Mr. Cray and Mr. Goodsell have look into the cost of replacing the wood chips in the **play area** with **soil and grass**.

9.2 Treloar site visit: Mr. Wells and Mr. Goodsell agreed to attend

9.3 Planning applications highways response: The Clerk was asked to write to the Leader of Hampshire County Council to say that Hampshire Highways had not responded to the recent Treloar site and the West End Farm applications, to ask who was responsible, and to say that their comments would have been helpful to Froyle councillors.

ITEM 10 MATTERS RAISED BY RESIDENTS

10.1 Mr. Lloyd reported that a resident had mentioned that the **public footpath from the quarry to Husseys Lane** had been ploughed over and not reinstated. Mr. Goodsell explained that the ground had been too wet to do so at the time, but that it will be reinstated.

10.2 Stiles: Mr. Whines said that a resident had reported the condition of the stile at the south east corner of the quarry in Lower Froyle. The owner of the stile had told him it would be repaired. Miss Gove agreed to talk to the footpath officer at HCC to get his/her advice on what FPC can do to make the quarry footpath easier for the infirm. Miss Gove reported on the stile on Saintbury Hill regarding putting in a rope hand rail. She explained that it is the responsibility of Froyle Estate, whose agent had explained that because it is on a steep slope, it is not advisable to put in a rope hand rail. Once it degrades, it could break if someone was hauling him/herself up on it.
