5.1 Planning Applications

- 286 **55541/004 Froyle Park**, Upper Froyle, Three dwellings with associated car parking following demolition of existing flat roofed workshops.
- 298 **55541/004** Amendment to Planning Application **55541/004** Froyle Park, Ryebridge Lane, Upper Froyle, Three dwellings with associated car parking following demolition of existing flat roofed workshops.
- **47 15-16** It was **RESOLVED** to **object** to this application for the reasons previously circulated to councillors, in summary as overdevelopment that adversely affects the Conservation Area and the setting of Listed Buildings, and which is ultimately not sustainable within the village as a whole.
 - 290 **20107/091 Froyle Park**, Upper Froyle, Variation of condition 23 of 20107/061 to "Low frequency music levels shall comply with the external noise targets of 44db leq 63hz 5 min and 45db leq 125hz 5 min and 39db LAeq 5 min overall" unless otherwise agreed in writing by the Local Planning Authority.
- **48 15-16** It was **RESOLVED** to **object** to this application for the reasons previously circulated to councillors, in summary because the noise limits being applied for now are higher than the original limits imposed in Condition 23, which aimed to "protect the amenity of occupiers of nearby properties". Noise levels should be brought to a point that is acceptable to local residents.
 - 314 55541/005 Froyle Park, Construction of car park.
 - 328 Mr. & Mrs. Bulpitt Froyle Park: proposed car park support had been enclosed with the agenda.
- 49 15-16 It was RESOLVED to object to this application for the reasons previously circulated to councillors, in summary because the site is the most sensitive in the Upper Froyle Conservation Area being bounded by three listed buildings; the site is located in parkland outside the settlement boundary where development would not normally be permitted; the proposal would interfere with distant views of Froyle Park (Grade II*) and St Mary's Church (Grade 1); the car park would lie close to the memorial garden for children of Treloar School and it is essential that the peace and tranquillity of the garden be preserved. Froyle Parish Council reserves the right to make further comments on this application if and when details of access and exit are forthcoming.
 - 326 **56422/001** Froyle Nature Conservation Group Formation of **wildlife pond** (FUL), Pond, Gid Lane, Upper Froyle.
 - 319 B. Clark: Gid Lane pond information had been enclosed with the agenda.
 - Mr. Clark explained that the S106 £20,000 was for the construction of the pond; the aim of the project is to encourage biodiversity; there had been a verbal agreement regarding access and the Conservation Group had requested a written agreement on access from the landowner.

Concern was expressed regarding access, insurance for repairs, responsibility for the pond if the Conservation Group ceased to exist, control of the site after planning permission is

- granted. The necessity of having a written agreement with the landowner ensuring access to the pond was noted, and that this should be passed to any future owners. It was noted that this may require an easement registered with the Land Registry.
- **50 15-16** It was **RESOLVED** to make **no objection** in principle to this application, but to comment that EHDC should draw up the agreement on access to the pond, and ensure that the S106 money that is tied to this project is used for the community.
 - 330 **56394 HSE 1 Miller Lane**, Upper Froyle, Detached double garage, alterations to existing patio doors, removal of existing pergola and replacement timber gate.

- 52 15-16 It was RESOLVED to object to this application because it would result in loss of amenity to neighbouring properties because of loss of light; because it increases by more than 50% the footprint as the calculation does not take into account the existing southern extension; because it damages the setting of a listed building, as in HE12.

6.4 Speedwatch 296 Mr. Robertson

Mr. Robertson reported: Residents' concerns over the speed of vehicles were recorded in the Parish Plan. The Speedwatch team used a moveable sign which showed that approximately

15% of drivers, both resident and non-resident, exceeded 36 mph, to whom the team would write. Drivers tended to slow down when they saw the sign.

If a permanent signs were adopted it would be fixed and connected to mains electricity, or moveable and use solar power. The team recommended a moveable sign so that drivers would not know where it might be. A chip inside records information regarding speed etc., but not vehicle registration numbers. It does not record cyclists' speeds.

The device could be attached to a post, but it is not permitted to attach anything to traffic signs etc, and permission to erect one's own post would take a long time. Suggested sites were near the Village Hall, the Anchor, and Froyle Park. If there were no delay with the posts, it could be installed by the middle of summer.

It could be financed by developers' contributions reserved for transport or ask the Department of Communities and Local Government for a grant. The maximum cost would be approximately £4000. It was suggested that suppliers could make a presentation of their devices.

Mr. Robertson also suggested that the team could clean and repair existing road signs, for an approximate cost of £100.

The Speedwatch team were thanked for their work.
