A resident reported that much traffic for the wedding venue still enters the Linden Homes estate. There was discussion of the wedding venue postcode and signage. It was agreed that Mr. Maher would ask Linden Homes to erect a sign at the entrance to Fiennes Lane (old Gate A) saying no access to hotel, and to ask Linden Homes to ask Froyle Park to arrange for there to be a sign on the verge of Hen & Chicken Hill directing drivers up the hill to the wedding venue, as Froyle Park wedding venue traffic could cause accidents in the Linden Homes estate.
