It was reported that the rumble strips had been installed, but the differently coloured surface of the private estate road still encroaches on the highway, due to having to fill the camber, and that the colour is different from that shown on the plan. It was agreed that a white line would indicate the junction, but this could be a Highways responsibility. It was noted that the traffic could increase when the new houses are all occupied, and that there is some extra traffic due to visitors mistaking the entrance for the entrance to the wedding venue.

ITEM 9 REPORTS FROM COUNCILLORS AND OFFICERS

9.1 Mr. Whines: the <u>Village Hall</u> Management Committee had decided to buy new <u>doors</u> for the village hall. He suggested the parish council might want to support this. A new village hall <u>bookings</u> secretary was needed. Hampshire Fire and Rescue Service chief officer had offered to give a talk to residents on fire <u>safety</u>. It was <u>agreed</u> that the parish council could organise this, early in 2018. It was <u>agreed</u> that HFRS should be asked whether they know where the fire hydrants in Froyle are.

ITEM 10 MATTERS RAISED BY COUNCILLORS

- **10.1** Mrs. Southern: <u>War Memorial</u> repairs: <u>Mr. Deans</u> to ask EHDC re planning. <u>Mr. Macnabb</u> to ask landowner about accessing the War Memorial via the field for transporting materials.
- **10.2** Mrs. Southern: <u>recreation ground mowing</u>: Mr. Macnabb had spoken to Mr. G. Wells and given the key to the gate to Mr. Wimshurst who is unable to mow it yet.

10.3 Aviation fuel pipeline from Southampton to London: projected route change consultation. It was noted that Esso would be in touch early in the new year regarding the consultation process.

ITEM 11 MATTERS RAISED BY RESIDENTS

11.1 Ditches There was discussion of the ownership of the ditch on the southern side of the recreation ground and the ditch by the side of Park Lane. It was reported that the ditch by the recreation ground was blocked.

<u>Mrs. Southern</u> to ask residents of Park Lane regarding ownership of ditch. <u>Mr. Macnabb</u> to ask Mr. Wells about the recreation ground ditch.

- **11.2 Dumping of garden waste** on Hen & Chicken hill verge from new housing. **Mrs. Southern** to write to the owner.
- **11.3 Speedwatch group** Mr. Deans reported that there had been a meeting to review the year's results. The Speedwatch group will be recruiting new members for 2018 and investigating alternative speed control measures. They will report to the PC in due course.
- **11.4** Damaged wall at top of Hen & Chicken Hill: to be repaired.
- **11.5 Wildflower area** Discussion of extension position re fête area, bench, gap between areas to allow mowing. **Mrs. Southern** to ask Mr. Clark.
- 11.6 Recreation Ground, trimming of trees, and brambles in hedge need to be cut back. Mr. Macnabb.
