# 5.5 Review of Clerk's salary

Clerk's letter of appointment for 1<sup>st</sup> June 2003: Clerk's salary for the current year to be reviewed annually at the November meeting of the Parish Council, to be paid at the appropriate rate recommended by NALC and the Society of Local Council Clerks, calculated from NALC Scale LC1 using the appropriate Spinal Column Point (SCP) up to the maximum of SCP21, commencing at Spinal Point 16.

It was <u>agreed</u> that the figure for insurance should be the same as in 2016-17, to increase the amount for replacement of play equipment, to use the latest CPI figure for the final budget in January, and to consider increasing the precept.

# 5.9.1 S137

298 2.11.16 HALC Reply to Clerk query: no info on new S137 limit yet available: when the figures for 2017-18 are available HALC will notify all member councils, in the meantime for draft budget purposes they suggest increasing current figure by 6p per elector, but the budget should be adjusted when the official

figures are released. Limit for 2016-17 is £7.42 per elector. With suggested increase of 6p per elector, limit would be £7.48.

Electors 475 at 1.12.15, 28 additions and 4 deletions April 2016 = 499. 499 x £7.48 = £3732.52

# **ITEM 10 MATTERS RAISED BY COUNCILLORS**

- **10.1 TAG Farnborough**: Mr Deans will prepare a presentation on for the January parish council meeting.
- **10.2 Devolution**: it was agreed that a councillor should attend the HALC meeting.
- **10.3 Froyle Park:** Replies had been received Miss Debenham and Mr. Hassett, but it was not considered that they had answered the pc's queries on the management for the car park. It was suggested that Mr. Findlay QC should be asked how much he wishes to be involved and its implication for billing.
- Mr. Whines queried the status of the original supplementary guidance. A timetable was needed from EHDC otherwise FPC would need to pursue the matter, go to Stage 2 complaint and thence possibly to the Ombudsman.

There was discussion of the likely basis for EHDC's decision and it was considered that EHDC should provide evidence for it.

<u>Mrs. Southern</u> to telephone Miss Debenham to ask when she might meet FPC as she had met NJG, when EHDC might come to a decision, and whether it was considered time to issue an enforcement notice. Miss Debenham would be asked first, then Mr. Hassett. <u>Mrs. Southern</u> to write to Dist.Cllr. Glynis Watts. <u>Mr. Whines</u> to draft a letter to the MP. <u>Mr. Whines</u> to ask Democratic Services whether a stage 2 complaint would be out of time.
