It was agreed that this item should be discussed at the next parish council meeting.

6.2 Hedges

<u>Hedge on Ryebridge Lane between the village hall and Hadwick's Corner.</u> Discussion deferred from FPC 6.8.12.

It was discussed whether to cut the hedge to just above the height of the fence next to it, and then to let some trees to grow within it. It was agreed that **Mr. Lloyd** would put a notice in the Village Magazine asking whether residents had any objections.

Beech hedge on Ryebridge Lane bordering playing field. It was agreed that Richard Hoare would be asked to cut in February, to include the short length at the village hall car park next to the storage container.

6.3 Treloar site sale

The Services Director and the Chairman of the Treloar Trust had met Mr. Wells and Miss Gove to report on the sale of the Treloar properties in Upper Froyle. The main site with the fields on the other side of the Hen & Chicken are being sold separately from the White House and Colthouse and Cattleys. Ryebridge Cottages and the Memorial Garden will be retained by the Treloar Trust. The buyer of the main site would like to meet the parish council.

- **8.1 Map and board**: Mr. Whines reported on quotations he had received and a grant of up to £1000 from Mr. Kemp-Gee and other grants available. **Miss Gove** would ask the Treloar Trust if they would make a donation towards the map and board for which they would be acknowledged. It was reported that the Treloar Trust had said it does not own Jubilee Green, the land on which the board is sited, and it was not known therefore who does own the land. It was agreed that the **Clerk** would get appropriate forms from the Land Registry to register Froyle Parish Council as the owner of Jubilee Green.
- **8.2 Village Hall**: Mr. Whines reported that the management committee are raising money for refurbishment and new curtains and have applied for grants to fund them. They had been given Mr. Law's map of the village, which would probably be hung in the village hall.
- **8.3 Car park**: The fête committee might purchase a storage container to put in the car park.
